DISH'S 2-YEAR TV PRICE GUARANTEE PROMOTION**

<p><u>Term Commitment</u></p>	<p>You acknowledge and agree that you are entering into a new twenty-four (24) month term commitment that will begin on the date on which you accept this offer by checking the “I accept” box below and that will end twenty-four (24) months later.</p>																																		
<p><u>Early Termination Fee</u></p>	<p>In the event that, prior to the end of your new twenty-four (24) month term commitment: your DISH service is disconnected for ANY REASON (for example, and without limitation, if you cancel your DISH service because you move to a location where you cannot receive your DISH service), and in either case, all programming and other prices, fees and charges for your new twenty-four (24) month term commitment have not yet been paid in full, then you agree to pay, and DISH will automatically charge, an early termination fee to your DISH account or your Qualifying Card (as defined in your Promotion Agreement), if any, at DISH’s option.
