

DISH “COPA EN CASA” SWEEPSTAKES

OFFICIAL RULES

Please read the Official Rules and Regulations (“Official Rules”) of the “DISH ‘Copa en Casa’ Sweepstakes” (“Sweepstakes”). You must agree to accept and comply with the Official Rules to participate in the Sweepstakes. By entering the Sweepstakes, you agree to these Rules.

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. 1. **Dates:** This Sweepstakes is valid from 5/25/26, 12:00 AM MT, through 6/7/26, 11:59 PM MT (“Sweepstakes Period”).
2. **Eligibility:** This Sweepstakes is open to legal residents of forty-six (46) contiguous United States and D.C. (excluding, without limitation, residents of New York, Florida, Hawaii, Alaska, Puerto Rico and other U.S. territories) who are 18 years of age (or age of majority in his or her state) and older at the time of entry. Employees, directors, officers and their immediate families (spouse, parents, children, siblings, and each of their spouses regardless where they live) or members of households of MARCA Miami and DISH Network L.L.C.  - b) Social Media (for existing DishLATINO Subscribers): Follow @dishlatino and comment your favorite DishLATINO feature on DishLATINO’s Copa En Casa giveaway social media post or on participating influencer Copa En Casa giveaway post(s) published by TheSalgueroFam, Los Chicaneros, Madres en Cuarentena, or Abelardo Campuzano and tag three (3) friends in your comment. Include the hashtag #Sweepstakes in your comment to validate your entry. If eligible, you shall be directed to enter certain information into an entry portal.
 - c) Mail – Entry may be accomplished by hand printing your full name, street address, city, state, ZIP code (no P.O. Sponsor and/or Administrator's discretion during the term, and will have 24 hours to respond. If a Potential Winner does not reply within allocated time, does not accept prize, or is found to be ineligible or not in compliance with these Official Rules such prize will be forfeited and may be awarded to an alternate Winner, time permitting. Odds of winning will depend upon the total number of eligible Entries received. Limit one (1) prize per person, per DISH account if applicable.

0. **Prizes and Approximate Retail Values ("ARV"):** Fourteen (14) 75" TVs with an ARV of \$500 each.
0. **Taxes:** All federal, state and local taxes and any other costs and expenses are the sole responsibility of each Winner. All expenses associated with prize acceptance and use not stated herein are the sole responsibility of each Winner. Prize Winner may (for prizes above \$600) be required to fill out and sign an IRS W-9 form and the information contained therein will be used by the Sponsor or their representative to complete an informational report for the IRS, such as a 1099-MISC form.

Any person attempting to damage any website, defraud or in any way tamper with the Sweepstakes will be ineligible for any prize and may be prosecuted to the full extent of the law. Sponsor or Administrator shall not be responsible for technical, pictorial, typographical or editorial errors or omissions in any marketing materials or these Official Rules.
