



EXISTING CUSTOMER DISH'S FLEX LOCK OFFER +

Term Commitment: You acknowledge and agree that you are entering into a new twenty-four (24) month term commitment for the Price Guarantee Programming Package (the "Term Commitment"). This Term Commitment begins on the date you accept this offer and will end after twenty-four (24) months of active DISH Service.

Early Termination Fee: If your DISH Service is disconnected prior to the end of your new Term Commitment for ANY REASON (for example, and without limitation, if you cancel your DISH service because you move to a location where you cannot receive your DISH service) and any programming or other fees and charges related to your new Term Commitment have not been paid in full, then you agree to pay, and DISH may automatically charge, an early termination fee to your DISH account or your Qualifying Card (as defined in your Promotion Agreement), at DISH's option. The early termination fee will be prorated by multiplying \$10 by the number of months remaining in your new Term Commitment. Notwithstanding your term commitment, DISH will not charge you an early termination fee if you disconnect your DISH service within 24 hours after you accept the terms and conditions of this Agreement. **The maximum early termination fee is \$240.**

Flex Lock Offer + Price Guarantee: Notwithstanding any pricing terms and conditions of your Promotion Agreement and/or Residential Customer Agreement to the contrary and subject to the terms and conditions set forth in this Flex Lock Offer +, by agreeing to participate in DISH's Flex Lock Offer +, DISH will not change, at any time during your Price Guarantee Period (as defined below), the price you pay for the Price Guarantee Programming Package below.

****Agreements with programming suppliers may expire during the term of your Term Commitment with DISH. If that occurs, some programming in your DISH services may not be available for some or all of the remaining term of your Term Commitment with DISH, and you will not be entitled to any refund, credit, or other compensation, as more fully set forth in the Residential Customer Agreement.**

****DISH has the right, without notice at any time and from time to time unless otherwise prohibited by law, (including, without limitation, during any term commitment to which you have agreed), to add, delete, rearrange, alter, change**

and/or eliminate: (A) any and all prices, fees and/or charges; and/or (B) packages, programming, programming suppliers, services offered by suppliers, software, applications, features and/or functionalities; provided that, in doing so, DISH exercises its discretion consistent with the parties' reasonable expectations at the inception of this agreement in accordance with the covenant of good faith and fair dealing implied in this agreement under Colorado law.

***You may not combine multiple Netflix-based Qualifying Channel Pack Options. Notwithstanding anything in this Flex Lock Offer + to the contrary, if you select a Netflix-based Qualifying Channel Pack Option, then you will receive up to a maximum of \$8.99 in monthly Commitment Credits in connection with your Netflix plan. If the monthly cost of such Netflix plan is less than \$8.99, then your monthly Commitment Credit will be reduced to not exceed the then-current monthly cost of such Netflix plan. If the monthly cost of such Netflix plan is greater than \$8.99, then you will be charged the difference between \$8.99 and the then-current monthly cost of such Netflix plan.

Flex Lock Offer + Additional Terms:

Your "Price Guarantee Period" begins on the date you accept this offer and expires twenty-four (24) months later. Upon the expiration of your Price Guarantee Period, you will pay the then-current price for your programming package. Your "Channel Pack Credit Period" will be effective no later than forty-eight (48) hours after the date you accept this offer and expires twenty-four (24) months later. Upon the expiration of your Channel Pack Credit Period, you will no longer receive any Commitment Credits for your then-current selected Qualifying Channel Pack Options. DISH will not extend your Price Guarantee Period or your Channel Pack Credit Period for any reason. During your Channel Pack Credit Period, you may modify your selected Qualifying Channel Pack Options from time to time and at any time (subject to availability); however, you will only receive monthly Commitment Credits for up to four (4) Qualifying Channel Pack Options.

If you participate in DISH Pause, or any other program that allows you to temporarily suspend your DISH Service, your Price Guarantee Period and Channel Pack Credit Period will automatically terminate and you will no longer be eligible for the Price Guarantee Programming Package or Commitment Credits. Upon reactivating your DISH Service after participation in DISH Pause or other similar program, you will pay the then-current price for your programming packages and you will not receive any Commitment Credits. Participation in DISH Pause temporarily pauses, but does not terminate, your Term Commitment. Your Term Commitment will expire only after twenty-four (24) months of active Service. DISH's Flex Price Lock + applies only to the Price Guarantee Programming Package. In the event that you change your underlying programming package following your acceptance of this offer, you will pay the then-current price of your new programming package and you will no longer receive Commitment Credits.

Additional Netflix Specific Terms: In order to be eligible to select a Netflix-based Qualifying Channel Pack Option, you must be a customer of DISH in good-standing, sign-up for Netflix through DISH, and activate your Netflix account. For existing Netflix customers who are currently subscribed directly through Netflix or a non-DISH third-party billing partner, you may still include a Netflix-based Qualifying Channel Pack Option by selecting the appropriate Netflix-based Qualifying Channel Pack Options and linking your existing Netflix account to your DISH package via an activation link, through the DISH website, or via your DISH receiver. It may take one (1) billing cycle to switch your Netflix billing over to DISH during which time you will continue to be charged separately for any existing Netflix account. If you link an existing Netflix account to this offer, terminating your DISH Service will not automatically cancel your Netflix membership, and Netflix will automatically resume charging your existing payment method that they have on file.
